Cookie Booth Information:

- Girl Scouts will be courteous to all customers and respectful of your location's space.
- Girl Scouts will be accompanied by at least two adults.
- Cookie Booths are generally listed in two hour increments.
- Booth dates and times selected by troops will be listed on the Cookie Finder App.
- Please note, not all the times and dates may be selected by troops.
- Booth cancelations (due to weather, etc.) should reflect in the Cookie Finder App.
- Troops will encourage touchless payment methods to minimize cash handling.
- Troops will clean and disinfect frequently touched surfaces and are expected to wash/sanitize hands often.
- Girls are required to limit close contact with others and maintain proper distancing from customers.
- Girl Scouts requires all participants to wear cloth face coverings during booths.
- Troops are responsible for bringing their own table, signage, and safety supplies.
- Troops will leave the location as they found it, removing all trash and recycling.
- The girls are covered by Girl Scout insurance while participating in this program.



To ensure the health and safety of not only our Girl Scouts, but also your business's customers and staff we have added COVID-19 protocols to the Booth Guidelines that our troops receive. We will continue to monitor and evaluate the current health environment and may adjust these protocols throughout the program.
